Attached you will find two pages presented during court, and never discussed with the Lakewood School District, titled "*Summary of Lakewood Public School District Settlement Agreement for Disenrolled Students.*"

The District has been informed that Ms. Catherine Anthony of the NJDOE, under the direction of her Supervisor, Dominic Rota, created the list.

In the District's effort to do its due diligence, and verify all students, and the information provided, I am hereby requesting the following:

- ◆ A copy of all files on the attached NJDOE maintained list title, "*Summary of Lakewood Public School District Settlement Agreement for Disenrolled Students.*"
- ◆ The "Exact" method in which was used to determine the cost of each student's agreement to the District, as Ms. Anthony was unsure as to what determines the length of an ESY program. For example on the chart it states 1 + 2 ESY, please clarify as to what that means specifically, and how it effects the cost of each students agreement.
